INSTRUCTION TO TENDERERS

1. SCOPE OF WORK

- 1.1 Fabrication of West side Partition wall, Shelter works in Material Inward and Rolling shutter for Material Inward of CODISSIA Defence Innovation and Atal Incubation Centre (CDIIC), at Codissia Trade Fair Complex (Hall C), G.V. Fair Grounds, Avinashi Rd, Coimbatore, Tamil Nadu 641014
- 1.2 The framework should preferably be made of Branded pipes of steel material and also with branded Galvanised sheet as per Annexure V
- 1.3 The making of framework would be carried out at the vendor's site only.
- 1.4 The vendor must ensure to take precise measurement and adhere to requirement of the CDIIC
- 1.5 The vendor must ensure proper installation of Fabrication work at the designated place as per CDIIC's direction.

2. QUALIFYING REQUIREMENT

- 2.1 Bidder shall be a registered company under the Indian Companies Act, 1956/ proprietary / partnership / Joint Venture firm. Documentary evidence regarding status of the firm shall be submitted.
- 2.2 The bidder shall be a Company / Firm / Individual specialized in making of high quality fabrication work.
- 2.3 Bidder should have valid PAN and GST Number. The bidders shall submit the copies of the same in the Bid. (Annexure I)
- 2.4 Duly filled and signed copy of Bidder Information and Tender Acceptance Letter as per Annexure I and Annexure IV respectively.
- 2.5 The Bidder has not been blacklisted by any of the Government Organization(s) / Public Sector Undertaking(s) (PSUs). Undertaking to this effect shall be submitted along with the bid as per **Annexure III**.
- 2.6 The Tender document shall be submitted in single cover as per Annexure II.
- 2.7 Bidder must comply with all the criteria as mentioned at clause 2.1 to 2.6.
- 2.8 Non compliance of any of the criteria shall result in rejection of the bid. Any hiding/misrepresentation of facts may result in rejection of the bid.

- 3.2 Duly filled copy of this tender document signed by the authorised signatory of the bidder on each page.
- 3.3 Complete Bill of Material(BOM) of the structural frames has to enclose in the tender document
- 3.4 Bidder information in **Annexure-I** duly stamped & signed.
- 3.5 The Tender document of Annexure I & Annexure II complete in all respect shall be in sealed Envelopes. Sealed Envelopes shall be subscribing "Bid for Shelter works in Material Inward and Parking area"

- 3.6 The sealed duly filled Tender document shall be submitted to The Director, CODISSIA Defence Innovation and Atal Incubation Centre (CDIIC), CODISSIA G.D. Naidu Towers, Huzur Road, Coimbatore- 641018 on or before Bid Submission date.
- 3.7 The Vendor's must observe the premises (CODISSIA Trade Fair Complex -Hall C) to take measurements and to ascertain the nature of work space to be made and accordingly quote in the Tender document. Inspection can be done on any working day before 18-Aug-2021, between 11:00 AM to 5:00 PM with prior permission/intimation to this office.

4 AWARD OF CONTRACT

4.1 LOWEST SUCESSFUL BIDDER

4.1.1 On completion of evaluation process of Bid, the Bidder whose Evaluated Amount is found to be the lowest would be declared as the Lowest (L-1) bidder.

4.2 LETTER OF INTENT (LOI)

- 4.2.1 The L-1 bidder will be considered for issuing of Letter of Intent (LOI).
- 4.2.2 The acceptance of the LOI shall be submitted within 5(five) working days from issue of LOI, failing which the Department reserves the right to cancel the LOI.

5 GENERAL TERMS CONDITIONS

- 5.1 The bidders have been permitted to tender on the explicit understanding that they shall not be entitled to resettle unilaterally from their offer or modify the terms and conditions once the same have been received in this office.
- 5.2 The bidder shall ensure that no damage is caused to the office documents/equipments and other items during the performance of his services/ any loss suffered therein will be made good from the vendor.
- 5.3 The Director CDIIC, reserves the right to reject any or all the bids without assigning any reasons.
- 5.4 If the bidder fails to render any or all the services as per tender, the Director CDIIC reserves the right to get the services executed at the risk and cost of the firm.
- 5.5 The bidder will be responsible for any loss, damage or liability due to lapse on the part of its employees.
- 5.6 The CDIIC Team will have the right to inspect the quality of work and material to be used for rendering the service.
- 5.7 In case, the bidder fails to render satisfactory services, the CDIIC reserves the right to take necessary action including termination of the allotted work.

- 2 Financial Proposals will be checked for computational errors or material/component/accessories omissions, and prices will be corrected and adjusted as necessary. In the case of material/component/accessories omissions, the cost of the relevant Financial Proposal will be decreased by application of the highest unit cost and quantity of the omitted item as provided in the other submitted Financial Proposals.
- 3 CDIIC reserves the right to use the same awarded vendor at specified approved costing in the tender for any extension works if needed.
- 4 CDIIC reserves the right to reject, at its sole discretion, any or all evaluated Financial Proposals and if necessary call for submission of new Financial Proposals. In order to allow comparison on a common basis, each Financial Proposal will be carefully scrutinized and Evaluated Tender Price for each Financial Proposal will be determined.

SPECIFICATION AND SCOPE OF WORK

Details:

Specification of the West Side partition wall in Hall C (1of 3)

- 1) MS Steel Structural frames of double column is integrated by welding using of the Sq. pipes 40mm 1.6 Thk with the base plates of 5" square of Thickness: 6 mm
- 2) Each frame is grouted on the floor with the fisher bolts of Dia. 10x75mm lg 8 Nos
- 3) All the double column frames are integrated with the Sq.tube of 40 1.6 Thk. Horizontally
- 4) Four horizontal pipes on the front and back side of the frame to be fixed with the bolting provision.
- 5) Opened ends of all the pipes should be cover with the welded sheet or Suitable plastic covers
- 6) All the frames have to coat with the aluminum painting for rust proofs before fixing the Galvanize Sheet.
- 7) Galvanize Sheet (Non color) of Thick 0.47mm (make: JSW) is used for the masking the partition and the same is fixed with suitable screws in the 40 sq. pipes
- 8) Single doors of 4 feet width are fixed with additional posts in between the partition wall with steel frame and GI sheet for masking with locks provision (lock should be inner side)
- 9) Suitable fabrication to be done in the Single doors and partition wall, to ensure without any visual gaps after closing.
- 10) Frame construction of partition wall has to lay for the length of 60 feet and the height 8 feet

Specification of the Shelter – Material Inward in Hall C (2 of 3)

- 1) Shelter area: 16.5 feet x 16.5 feet.
- 2) Height of shelter: Starts with 12 feet from wall and end with 11.5 feet for free water draining
- 3) Top Covering with the Galvanized sheet of 0.45mm thickness (Non color)
- 4) End of the sheet to curved of radius 0.5 feet (one quarter)
- 5) Supporting pipe size (4 No's): Square 3 "pipe, Thickness: 1.6 mm
- 6) Size of the Cross laying pipes (7 No's) on the top side : 3" x 1.5 " rectangular pipe (16.5 feet length) Brand : Apollo or Neosun
- 7) Shelter supporting pipes to be fixed at the specified place mentioned by CDIIC
- 8) Opened ends of all the pipes should be cover with the welded sheet or Suitable plastic covers
- 9) Supporting pipes to be fixed on the ground with suitable supports
- 10) All the frames have to coat with the aluminum painting for rust proofs before fixing the Galvanize Sheet.
- 11) Water Leaking should be arrested after laying the sheet at the wall side

Specification of the Rolling shutter in Hall C (3 of 3)

- 1) Size of rolling shutter: 11 feet x 12.25 feet.
- 2) Leaf Thickness: 19 gauge 1mm (Medium)
- 3) Leaf structure: Curved
- 4) Closing type: Manually operated open and close shutter
- 5) Locking method: Key lock at the middle and Lever locks on both side
- 6) Suitable Covers to be provided at the top of the rolling shutter
- 7) Rolling shutter to be fixed inside the Hall C at the specified place mentioned by CDIIC
- 8) Rolling shutter to be fixed with suitable clamps and channels
- 9) Branded shutter to be used
- 10) Lubrication detail to be mentioned for smooth operation of shutter
- 11) After fixing the shutter the Aluminum painting should be coated on both sides for rust proof.
